

THE R. BRINKLEY SMITHERS AWARD

As a permanent special memorial to our Founder, the Foundation established the R. Brinkley Smithers Award which reads "For outstanding contributions to the field of alcoholism." In addition to a commemorative bronze medallion, the Foundation will give \$10,000 to a charity in the field of alcoholism named by the recipient.

The recipients for 2006 were:

Mrs. Martha Baker

In the early 1970's, Marty Baker was one of the founding trustees of The .Cleveland Center on Alcoholism, which then affiliated with the National Council on Alcoholism. Marty became president and chairman. Under her leadership the agency focused on public education about the disease of alcoholism, as well as its prevention, and instigated programs for children of alcoholics. Adult Children of Alcoholics was an outgrowth of this project. In the late 70's Marty's beloved late husband, Dick, joined the Board and was instrumental in establishing one of the first Employee Assistance Programs in the nation, which still operates nationally as a role model.

Marty joined the Board of the National Council on Alcoholism in 1978 and became the first woman president of this organization in the mid-80's. In her 22 years of service and leadership on the Board of NCADD, Marty, through her willingness to help and generosity to the cause, has served as a role model and an inspiration to the entire field.

Leadership to Keep Children Alcohol Free is a national, nonpartisan coalition whose mission is to promote the health, well-being and potential of the Nation's youth by preventing alcohol use among 9 to 15 year olds. *Leadership* is comprised of the Initiative (sitting Governors' spouses), the Emeritus Group (spouses of former Governors), and the *Leadership Foundation*, a notfor-profit philanthropy established in October 2004. The Board of Directors of the Foundation includes spouses of both former Governors and sitting cabinet members from both political parties. The Foundation recently opened its first office in Washington, DC. It is a grant-seeking entity.

Leadership was created to draw public attention to the problem of early alcohol use among 9 to 15 year-olds, with the Governors' spouses providing leadership as State and

national spokespersons. *Leadership* recognizes childhood drinking as a public health issue and seeks to make its prevention a national priority. Its members work with federal, state and local policy makers and opinion leaders to develop and implement comprehensive, integrated, evidence based approaches to help keep children alcohol free. Most recently *Leadership* has been collaborating with the American Academy of Pediatrics on a model program to help pediatricians address alcohol use among their patients. It is playing a major role in the support and dissemination of the Surgeon General's Call to Action on underage drinking. The *Leadership* is continuing to expand its outreach to new states and Governors' spouses.

Scott Clark

Scott joined Eyewitness News in 1986 and soon became the station's Sports Director and Anchor and is known to be "Out Of This World"! In fact, Scott's reporting exploits over the past 30 years have taken him around the world from Tokyo, Japan for Major League Baseball's historic season opener with the Mets, to England to cover The Championships at Wimbledon, and back across the United States to bring Channel 7 viewers the best Coverage of their local sports teams.

While at Channel 7, Scott initiated some of the funniest and most anticipated sports features with his weekly segments, "Out Of This World," "Highlight Zone" and "Armchair Quarter Back."

The Emmy Award winning sportscaster has not only nabbed exclusive interviews throughout the years, but has also covered sporting events first hand. Scott signed on and played with a professional football team. He has stood with bat in hand at home plate to face the likes of Doc Gooden and Goose Gossage and has played basketball against the Harlem Globetrotters. If that wasn't enough he's been a Drag Racer, Sky Diver, Bronco Buster, and yes, even, a Bull Riding Fool that earned him a week's stay in the hospital.

Off the air, Scott serves as Vice President on the Board of Directors of the Alcoholism Council of New York. In addition, he serves on the Advisory Board of the National Sportscasters Association, and the Board of Trustees of the Starlight Foundation, where he was recently inducted into its Hall of Fame.

New York's 1998 Big Brother of the Year, also loves to play golf, and has helped raise hundreds of thousands of dollars for charity by hosting his own golf tournaments over the years.

AWARDS RECEIVED

Over the years, Mrs. Adele C. Smithers, President of The Christopher D. Smithers Foundation, Officers of the Foundation and the Foundation itself have been honored with scores of national and international awards in recognition of their efforts to create public awareness of the disease of alcoholism.

Some of the recent activities in 2006 were:

On Wednesday, April 26, 2006 Mrs. Adele Smithers, President of The Christopher D. Smithers Foundation, had the honor of opening the futures market on the commodities exchange in New York City.

Ray Negron, assistant to New York Yankees owner, George Steinbrenner, wrote a children's book, <u>The Boy of</u> <u>Steel</u>. The book, about a child who has cancer, is dedicated to both Mrs. Smithers and George Steinbrenner. Adele Smithers and Ray Negron signed books at The Ronald McDonald House of Long Island located in New Hyde Park, NY, in August and at the Cradle of Aviation Museum in Garden City, NY, in September.

Adele Smithers was the honored guest at the Fifth Annual Long Island Festival & Walk for Mental Health on September 17, 2006, which draws thousands of participants from New York State. The Walk was held in Huntington, Long Island, and its purpose is to raise awareness and remove the stigma associated with mental health challenges.

The Fourth Annual Paws for Parkinson's Dog Walk was held in October at Marjorie R. Post Park, in Massapequa, NY. Mrs. Smithers helped judge the various canine contests. This event helps raise awareness of Parkinson's disease. The monies collected help fund pioneering research at universities and hospitals throughout the United States into the cause and possible cure for this devastating disease.

Some of the most recent awards are:

In 2006, The Long Island Council on Alcoholism and Drug Dependence celebrated its 50th Anniversary. The late R. Brinkley Smithers and The Christopher D. Smithers Foundation were honored at its annual Angel Ball with the 2006 Founder Award.

Adele C. Smithers, President, Christopher D. Smithers Foundation and longtime friend of the ILR School was presented the Jerome Alpern Distinguished Alumni Award at Cornell/ILR School Celebration 2006.

Adele Smithers, President of The Christopher D. Smithers Foundation, received the 2006 International Humanitarian Service Award from the Gift of Life, Inc., at its 31st Gala Dinner Dance for her "tireless philanthropy for the benefit of mankind, specifically in the areas of alcoholism, drug dependency and with children who are in need of cardiac surgery."

Adele Smithers was invited to attend The White House Conference on the Nation's Youth in October of 2005. Mrs. Laura Bush then invited Adele to The White House Breakfast on Helping America's Youth. She and The Christopher D. Smithers Foundation were cited for their outstanding work.

The Governors' spouses initiative, Leadership to Keep Children Alcohol Free Foundation, presented Adele Smithers with its first award in recognition of her commitment to our nation's youth in May 2005.

The Christopher D. Smithers Foundation and its President, Adele Smithers were honored with the Gilbert Tilles Award at the 18th Annual Long Island Philanthropy Day Awards Luncheon in 2005.

The New York College of Osteopathic Medicine and School of Health Professions, Behavioral and Life Sciences of New York Institute of Technology honored Adele Smithers with the Riland Medal for Public Service at the Osteopathic Medicine and Health Professions Convocation on September 26, 2005. The medal is awarded to individuals who have made significant contributions to the improvement of health care, medical research, health policy, osteopathic philosophy and community service.

Derek Jeter's Turn 2 Foundation presented Adele Smithers with its first "MVP Award" for "her unwavering commitment and support of the Turn 2 Foundation." The Turn 2 Foundation strives to create outlooks for today's youth to achieve academic excellence, develop leadership skills and remain drug and alcohol free.

St. John's Riverside Hospital in Yonkers, New York, honored her with its Community Service Award "in recognition of her tireless work on behalf of those afflicted with alcoholism."

The National Council on Alcoholism and Drug Dependence presented Adele Smithers with its prestigious "Gold Key" Award. This Award was established in 1959 to honor individuals who have made outstanding contributions to the field of alcoholism on a national level.

The Freedom Institute honored Adele Smithers at its Benefit Dinner with the Mona Mansell Award. The award reads, "With deepest gratitude for your extraordinary contribution to the field of alcohol and drug dependence. You have left your mark."

On National Philanthropy Day 2002 the Association of Fundraising Professionals cited Adele Smithers as one of New York's Finest Philanthropists.

Brinkley Smithers."

FOUNDATION GRANTS IN THE FIELD OF ALCOHOLISM

Adelphi University Garden City, NY

\$50,000

The grant monies received from the Smithers Foundation was utilized for the development of the alcohol prevention and intervention services for the under graduate population at Adelphi University, and for the creation of a plan for evaluation of programs and intervention effectiveness. During the fall of 2005, planning for the pilot project began, and the plans were presented to the Smithers Foundation and the Adelphi University Faculty.

In the Spring of 2006, Institutional Review Board approval was obtained to initiate program implementation. The following are the accomplishments related to the pilot program:

BASICS: Process and outcome evaluation instruments were developed: Readiness to Change, Alcohol Attitude and Environmental Survey, and a demographic and program reaction form. The AU e-CHUG website, an online survey which provides a detailed assessment of alcohol use, was tested and established. The counselors, who will implement BASICS, and clerical assistants, who will input data, were assigned.

The initiation of the pilot testing of BASICS started in June, 2006. Examining the process to date, the following issues have been identified: the referral process, which is primarily done through the office of judicial services, will be refined and expanded. Resident assistants will receive an orientation and debriefing regarding the program and follow up mechanisms will be institutionalized. In addition to the Assistant Dean of Student Affairs, an additional administrative assistant is needed to insure that the program is carried out.

CHOICES: Implementation and evaluation plans have been finalized. The program is presently being pilot tested for approximately six hundred and fifty freshmen in July. The freshmen who complete this ninety minute program will fill out a pre-test, a post-test, and course evaluation. In addition, the seven counselors who are implementing CHOICES will complete a process questionnaire to determine difficulties or problems. Concerns regarding the implementation of CHOICES are capturing commuter students and freshmen who did not attend orientation. Mechanisms to reach these students as well as at-risk students (fraternities, sororities, and athletes) are being, explored so that CHOICES can be administered to them in the Fall of 2006. Scholarly Outputs include three poster presentations given on campus about the project. These presentations were entitled: An Evidenced-Based Intervention to Reduce Campus Alcohol Consumption: A Program Evaluation. Another poster presentation is scheduled in the fall 2006 at the Connecticut Research Alliance and Institute of Health Care Education conference. A research assistant is reviewing the literature relating to alcohol prevention and use on campuses for manuscript development.

Resources and Future plans, for Program Development

Funding has been adequate in the planning phases of the program. After assessing the activities of the key individuals, it has been determined that a coordinator is needed to work with the individuals who make referrals from athletic teams, sororities, fraternities, the campus judicial system, dormitories, and health services. An additional assistant is required to conduct focus groups and other qualitative research methods, such as interviews, to evaluate the effectiveness of the program. These positions will be filled in the fall semester. Future plans for program development include a social marketing scheme to promote the existence of the programs and to educate students and faculty. An individual will be needed to proceed with this work. It is anticipated that a follow-up CORE survey, a university-wide alcohol use survey, will be administered to monitor program outcomes as well as identify barriers to the successful implementation of the program. Results of this survey will be compared to the baseline CORE survey done in 2005.

Alcoholism Council of New York New York, NY

\$52,920

A Smithers Foundation grant provided support for several programs which were overseen by the ACNY.

Physicians Alcoholism and Addiction Training Program in cooperation with the New York Affiliate of the National Council on Alcoholism and the Smithers Foundation and under the direction of Dr. Nicholas Pace training was provided for 66 primary care physicians from four New York teaching hospitals who have been instrumental in the training of residents and faculty in addiction programs.

Hospital programs participating included: NYU Medical Center's Departments of Pediatrics, Primary Care, and Categorical residents, Montefiore Medical Centers Department of Family Medicine, Lenox Hill Hospital's Department of Primary Care, and Mt. Sinai Medical Center. Lenox Hill continued sending their residents for the fifth year of mandatory training.

Participating hospitals continue to assume more responsibility for addiction-training programs in-house, while continuing to send residents to the training where they are paired up for three nights with a recovering alcoholic from Alcoholics Anonymous Cooperating with the Professional Community Committee(CPC). Pediatric residents were included in the PAAT training for the first time and some adjustments were made for the course to accommodate them. In an effort to accommodate the schedule of the NYU residents, the buddy time has been decreased to 2 evenings per week and residents start the program at 5:00 p.m. instead of 4:00 p.m. So far these adjustments are very beneficial and evaluations are positive about the time changes.

A plan was implemented in 2006 to recruit a more varied training faculty in order to create a self-sustaining program in New York City. Several additional psychiatrists were added to the faculty. A special focus was placed on the Standardized Patient Interview, adding the medical director of Substance Abuse Consultation and Referral at Montefiore Medical Center as one of three PAAT Standardized Patient facilitators. This brings the total to eight new faculty who have been selected, trained and added on a rotation basis; all of them are from New York University Medical School. All of the physicians in PAAT program provide a broad spectrum of alcohol and substance specialties. They continue to add faculty based on a balance of internal medicine/primary care doctors and psychiatry. Several doctors are also available each month for Standardized Patient interviews. Additionally, three individuals have assisted in the operation and on site considerations of the program under the direction of the PAAT Clinical Training Director, Janice Meredith,

The Substance Abuse and Mental Health Services Administration (SAMHSA) has contacted the PAAT and would like to do a research piece on the Standardized Patient Interview and will begin this process soon. They are very supportive of a national physician-training program.

The program is stronger as a result of careful analysis of handouts, revision of resident evaluation tools, updating handout materials, and experimentation with best method for getting materials to residents in advance to allow time for review. A new version of the graduation certificate includes the Alcoholism Council's new location. The year 2006 has resulted in an even more effective program with increased community support through the teaching hospitals and Alcoholics Anonymous. By the end of academic year 06-07 almost 400 residents from New York City teaching hospitals will have been successfully trained by the PAAT

Boys & Girls Clubs of Tampa Bay Tampa, FL

\$8,000

Grant funds were used for the implementation and expansion of the SMART Moves Program. SMART Moves provides training to help young people understand the dangers and to resist the use of drugs, alcohol and tobacco. The SMART Moves Program is a key element of the core programming offered to young people at each of our twenty four Clubs. It is designed to inform young people in a *positive* way, equipping them with basic life skills, problem-solving and decision-making abilities and communications skills that are all designed to boost selfconfidence and self-esteem.

SMART Moves uses age-specific modules that engage Club staff, parents, community members and older teen members in a team approach to prevention. Therefore, depending on age, Club members will participate in the following:

- SMART Kids, for children ages 6-9: Focuses on building self-esteem, positive social skills and the skills to avoid drugs and other harmful influences.
- Start SMART, for preteens ages 10-12: Presents information and skills needed to resist pressures to get involved in alcohol, tobacco, other drugs or sexual activity. Group members analyze influences from the media and from peers; they also practice resisting peer pressure.
- Stay SMART, for teens ages 13-15: Provides information about alcohol, tobacco, other drugs and sexuality and develops skills to help teenagers make healthy choices. Teens practice problem-solving and decision-making, stress reduction techniques, and ways to resist peer and media pressure.

In addition to the above mentioned is the Yankee Luncheon which the Foundation sponsors to help raise funds to restore and rebuild New Boys & Girls Clubs in the Tampa Bay Area.

Caribbean Institute on Alcoholism

And Other Drug Problems

Trinidad, W.I.

\$5,000

With a grant provided by the Smithers Foundation, the 52nd Caribbean Institute on Alcoholism and Other Drug Problems hosted 65 participants from Caribbean countries. The Institute brings together workers in the field of alcoholism and substance abuse from the entire Caribbean region, helping to provide a network of prevention and treatment services throughout the Caribbean. The Institute offered an intense two week Basic Course as well as a three day Specialized Workshop on "Youth Alcohol and Drugs."

The Basic Course covered a wide range of subject areas presenting up-to-date information on the nature of drug dependence: biological, psychological and socio-cultural aspects of alcoholism and drug dependence; and medical and other consequences of drug dependence. Lectures also focused on youth, alcohol and drugs; women, alcohol and drugs: children of alcoholics and drug abuse in the Caribbean context. There were updates on Cannabis, Cocaine, substance abuse and HIV/AIDS and other addictions.

The 3-day Specialized Workshop aimed to enhance the knowledge and skills of clinicians, other workers and policy makers involved with drug-using youth. This Workshop looked at Caribbean trends in youth drug abuse and addressed adolescent development and drug use, risk and protective factors, assessment and treatment planning and treatment and prevention approaches.

A wide range of occupations was represented in the student body. They included a psychiatrist, medical doctor, nurses, psychiatric social workers, police officers, counsellors, probation officers, prison welfare officers, drug education officers, research officers, guidance counsellors, mental health officers, programme directors, drug control officers and others working in the field of prevention and treatment.

International faculty was representative of the multidisciplinary nature of drug dependence and comprised four psychiatrists, four psychologists, a social worker, an educator, an employee assistance consultant and a member of the clergy, from Trinidad, Jamaica, USA and Canada. Paraprofessionals functioned as resource personnel.

Employment Program for Recovered Alcoholics, Inc. New.York, NY

\$15,000

The founding of EPRA by R. Brinkley Smithers and John H. Beard along with the support of The Christopher D. Smithers Foundation, enabled the missing link, namely the vocational recovery process, to be established almost 30 years ago. Even as treatment agencies add vocational components to their programs, EPRA remains unique in its approach by truly integrating sound recovery principles with the vocational rehabilitation process and ultimately self-sufficient, sustained employment that has the effect of reducing or eliminating relapse episodes.

The ongoing support of The Christopher D. Smithers Foundation over the years has aided EPRA in maintaining the vital mission of vocational recovery. In 2006, EPRA's Diagnostic Vocational Evaluation program served 372

clients with 120 of those clients entering our Internship (Situational Assessment) programs to gain experience in the everyday work world, as well as to address their barriers to employment. With respect to employment, 57 individuals became employed at an average hourly wage of \$13.32 per hour and 65% of those jobs offered medical benefits to their clients, through completion of a program evaluation survey, continue to express a very positive experience at EPRA.

Smithers Foundation funding has enabled EPRA to purchase special Vocational Evaluation equipment in this past year which will enhance its overall services. Recommended by line staff members of the State, this initiative has been well received by the New York State Office of Vocational and Educational Services for Individuals with Disabilities. It is hoped that the addition of this special testing will stabilize our current referral base and eventually result in an increase in the number of clients entering the program.

Recent levels of service at the Bronx Center, in its 3rd year of operation, now meet the requirements of the New York City Department of Health and Mental Hygiene. This is an important improvement as this contract expires next year and hopefully will be considered for renewal.

Glen Cove Boys & Girls Club

At Lincoln House, Inc.

Glen Cove, NY

\$50,500

This grant provided by the Smithers Foundation enabled the Boys & Girls Club to complete phase four of their Capital Campaign Improvement Projects, an outdoor multi purpose recreational facility and outside construction project. In addition the club provided the following youth development programs and services:

Power Hour

Homework help and tutorial services

Smart Moves

Drug & alcohol prevention workshops

Computer Education

Age appropriate activities including internet safety, educational games, internet research and computer applications.

Smart Girls and Passport to Manhood

Information and skills development workshops, necessary for healthy lifestyles for boys and girls ages 11-13.

To date the program has trained over 2,500 recovery ambassadors to reach out in their community. This luncheon is a premier event for the American public to see a positive face regarding alcohol and drug addiction, as well as promote anti-stigma work regarding addiction diseases.

Long Island Council on Alcoholism And Drug Dependence Williston Park, NY

This organization founded by R. Brinkley Smithers celebrated its 50th Anniversary in 2006, and with grants from the Smithers Foundation was able to continue its outstanding work for the residents of Nassau and Suffolk Counties.

The grant to LICADD helped to maintain the alcohol and drug abuse education and prevention programs as well as support the R. Brinkley Smithers Golf Invitational, the Angel Ball, and the Peter Sweisgood Breakfast. The Council has continued to fulfill R. Brinkley Smithers' mission of providing the best services available for children, families and individuals struggling to overcome the disease of alcoholism.

National Council on Alcoholism And Drug Dependence New York, NY

\$199,165

Support from the Smithers Foundation has been crucial to the success of the work and operation at the National Council, NCADD. Grant monies from the Foundation have enabled NCADD to provide support to over 95 affiliates throughout the United States. These affiliates provided help and hope to thousands of individuals and families across America dealing with alcoholism and other drug addictions.

In addition to the work previously, described, the Smithers grant was utilized for other over-all operating support which included:

- · A toll-free Hope line which received 40,000 calls
- The NCADD website had 4,291,539 hits
- Registry of Addiction Recovery (ROAR) provided support for conferences with affiliates from around the country working in the field of alcoholism and drug dependence.

The Smithers grants also supported board expenses, the

annual affiliate conference, NCADD's Hope, Help and Healing Campaign, and the affiliate training and media training programs.

National Council on Alcoholism And Drug Dependence San Francisco, CA

Below is a brief description on how the grant from the Smithers Foundation was utilized by NCADD, San Francisco, CA.

The purpose of the grant was to provide substance abuse education in five 50-minute sessions to 1,000 students in the public middle schools in San Francisco. The Youth Services Program was able to provide the curriculum to 1,108 students in 5 middle schools by the end of the 05-06 school years.

The curriculum was provided to schools with approximately 52% of the students utilizing the free lunch program therefore making the majority of the school population from low and moderate income families.

They were able to demonstrate that student's knowledge and awareness about the harmful effects of alcohol and other drugs increased when there was a 16% increase in overall knowledge about the consequences of using alcohol and other drugs between pre and post test scores. The group score was 76% on the pre test which increased to 92% on the post test.

They also set out to foster a positive change in participants attitudes toward alcohol and tobacco advertisements and strengthen the vitality of the community by reaching out to young people at a crucial age where drinking and drugging are high on the list of experimentation.

National Council on Alcoholism And

Drug Dependence of Middlesex County, Inc. East Brunswick, NJ. \$3,000

This Foundation grant assisted NCADD Middlesex County, Inc by helping them in furthering their mission in promoting good health and well being, through the reduction of elimination of alcohol, tobacco and other drug use and abuse problems. Some of programs are described below.

 Services to Schools - Footprints for Life program -Footprints for Life is a research-based primary prevention program that builds assets and teaches important life skills to students in grades two and three. Through the use of puppets and stories that feature "real life" situations experienced by a children's soccer team, the program offers many opportunities for students to practice the new skills they have learned in a fun and non-threatening way.

- Friends of Addiction Recovery Friends of Addiction Recovery-New Jersey seeks to overcome the stigma of addiction, and to honor, support, celebrate and promote the positive experience of recovery. We are committed to providing opportunities for recovering individuals, their families, friends and allies to empower themselves as agents and voices for service and change.
- Strengthening Families The goal of the Strengthening Families program is to prevent substance abuse in youth by helping them to build skills and giving parents more tools to help their children become responsible young adults. The program also helps families improve the relationship between parents and youth and decreases the level of family conflict.
- NCADD publishes an annual Resource Directory outlining ATOD service providers in our county.
- Middlesex County Substance Abuse Coalition The Middlesex County Substance Abuse Coalition brings together professionals from multiple disciplines who have a passion for the prevention and treatment of alcohol, tobacco, and other drug abuse problems. Their mission is to reduce substance abuse, especially among youth, by providing opportunities for increased collaboration, coordinated planning, and sharing of resources in order to maximize the quality and availability of services to the communities' and residents of Middlesex County.
- Information/Referral Hotline NCADD provides confidential, objective information and referral for individuals and family members who are seeking help for an alcohol or other drug problem. Staffed by caring certified professionals, our helpline reaches over 800 families annually.

New York Medical College

The Smithers Foundation has been associated with New York Medical College for more than three decades, supporting the outstanding research of Dr. Albert B. Lowenfels, Professor of Surgery and Community and Preventive medicine. He is recognized as one of the leading authorities on the disease of alcoholism and its effects on the liver and pancreas.

The following activities were performed in 2006 with grant support from the Christopher D. Smithers Foundation:

Teaching:

During 2006 Dr. Lowenfels continued all of his teaching activities at New York Medical College, affording him an opportunity to present information about alcohol, alcoholism, and alcohol-related diseases to students throughout all four years of their training. Dr. Lowenfels has a duel appointment (Surgery, Community and preventive Medicine). He can discuss practical patientrelated topics with his surgical students, and more general topics with students during their Community and preventive Medicine rotations.

Mentoring:

Dr. Lowenfels has been a mentor for a young gastroenterologist, Dhiraj Yadov, who is a member of the pancreatic research group at the University of Pittsburgh. They continue to work together on projects mainly related to alcohol and the pancreas. Dr. Yadov is responsible for the analysis of 1000 patients with well documented pancreatitis collected from 20 specialty centers in the United States. In 2006 they began the analysis of this valuable source of information about alcoholic pancreatitis.

North Shore Boys & Girls Club, Inc.

The finds from the Smithers Foundation were utilized to support the Club's 10th Anniversary of service to the community. This Club has grown in membership from 200 to 1600. It has also developed over 40 programs for youth ages 5 through 18.

Dr. Ernest Noble's research on the genetic basis of alcoholism and other drug addictions was funded by a Smithers Foundation grant in 2006.

Since the last report, some of the accomplishments made during the current grant period are described in the following report.

Identification of the unique cognitive behavioral and genetic characteristics of adolescent children of alcoholics has been one of the primary objectives of Dr. Noble's research during 2006.

In the first study, the P300, a. brain wave form that indexes cognitive abilities (the higher the P300 amplitude

and the shorter the P300 latency, the better the cognition) was measured in 71 adolescent children of alcoholics (those with a positive family history of alcoholism, or FH+) and adolescent children of non-alcoholics (i.e., those with a negative family history of alcoholism, or FH-). The P300 was obtained at time 1 (Tl) and 2 years later at time 2 (T2). Comparisons were made between children who had the D2dopamine receptor (DRD2) Al allele (Al+), an allele associated with alcoholism and other drug addictions, and children who did not have this allele (Al-). Comparisons were also made between FH+ and FH- children. In both testing sessions, P300 attained larger amplitudes in children of non-alcoholics than children of alcoholics. At T2 compared to TI, both amplitude and latency of the P300 were decreased. However, while the developmental P300 latency effect was equivalent in both the Al+ and Al- allelic groups, the P300 amplitude reduction was only found in children with the Al- aliele. In conclusion, differences in the developmental course of the P300 over the 2-year course of adolescence are dependent on DRD2 polymorphisms. Specifically, the brain of children with the DRD2 Al+ allele mature slower, so far as cognitive abilities are concerned, than children who do not have the DRD2 allele. This study was published in 2006 in the Journal of Clinical Neurophysiology.

White Bison, Inc utilized the grant from the Smithers Foundation for the printing of the book "Alcohol Problems in Native America: The Untold Story of Resistance and Recovery - The Truth About the Lie."

Feature articles and book reviews were published in Winds of Change Magazine, Counselor Magazine, Well Nation's Magazine, the Journal of the Center for Study of Addiction and Recovery, the Faces and Voices of Recovery (FAVOR) website and in Addiction, and the Journal of the Society for the Study of Addiction. The book was also advertised in two American Indian/Alaska Native print media, as well as in News From Indian Country.

The book focuses on the history of Native Americans and their resistance to alcohol because of the problems that Indians have with alcohol and alcoholism.

FOUNDATION'S OFFICERS

Adele C Smithers, President of The Christopher D. Smithers Foundation has devoted herself to the field of alcoholism since joining the National Council on Alcoholism in 1960. Mrs. Smithers is an activist for creating greater understanding of alcoholism as a respectable and treatable disease from which individuals can and do recover.

Outspoken when necessary, always compassionate and always a fierce advocate for the cause, she has been dubbed "the real godmother of the new style of philanthropy" ("muscular style") by **The New York Times** for her precedent setting work on behalf of charitable donors. Mrs. Smithers has also been dubbed the "godmother" of research, education, prevention and recovery in the alcohol abuse and dependence fields.

She is past chair of the Board of the National Council on Alcoholism and Drug Dependence, founding Chairman Emeritus of NCADD Tampa; Chairman of the Alcoholism Council of New York and Vice Chair of the Long Island Council on Alcoholism and Drug Dependence; member of the Board of Directors of the Employment Program for Recovered Alcoholics (EPRA), North Shore Boys & Girls Club, the William Edwin Hall Foundation, Tucson, AZ, Council Member of the Federation of Protestant Welfare Agencies, Vice President of the National Board of The National Institute of Social Services, NY.; Trustee of Portledge School, Locust Valley, NY and was a Director of the Family Service Association of Nassau County for eleven years. In November of 2001, Mrs. Smithers was elected to serve a three-year term as Honorary Director of Recovery Resources, Cleveland, OH.

She is a member of the Board of Overseers of the Grenville Baker Boys & Girls Club, Locust Valley, NY, Founding Member of the Palm Beach Guild for the Children's Home Society in West Palm Beach, FL; member of the Advisory Board of Gratitude House, West Palm Beach, FL; Patron of the Peggy Adams Animal Rescue League of the Palm Beaches and a member of the Board of the Humane Society of New York.

Additionally, she has worked and supported the innovative Parkinson's Disease Program at the New York College of Osteopathic Medicine of New York Institute of Technology and in 1998 the Adele Smithers Parkinson's Disease Treatment Center was named in her honor. She was also recognized by The Nassau County Chapter of The American Parkinson Disease Association for her contributions.

Adele Smithers is listed in the National Register's Who's

Who in Executives and Professionals 2003-2004 Edition.

She served in the United States Air Force from 1951-1954 attaining the rank of Staff Sergeant.

Over the years Mrs. Adele C. Smithers has made many personal contributions in the field of alcoholism and to other than alcohol related charities, which are not included in any of the grants made by The Christopher D. Smithers Foundation.

Mr. Thomas D. Croci, Vice President/Treasurer, was elected a member of the Foundation's Board in June 1 994. He is a graduate of The University of Montana and has an M.S. degree in Guidance and Counseling, Long Island University; a P.D., Long Island University in Administration and Supervision and is a graduate of the Rutgers University Summer School of Alcohol Studies.

He has served as a health teacher at Connetquot School District; Assistant Athletic Director, Connetquot School District; Assistant Principal, Connetquot High School; Assistant Principal, Cherokee Elementary School; and Principal, Edith L. Slocum Elementary School. He was a founding member of the Advisory Board for the Employees Assistance Program in the Connetquot School District.

Mr. Croci served on the Executive Dinner Committee for Derek Jeter's Annual Turn 2 Foundation Dinner and the Committee for the Physicians Alcoholism Treatment and Training Program for the Alcoholism Council of New York. He also serves as secretary for the Long Island Council on Alcoholism and Drug Dependence.

In 2006 The Connetquot Foundation for the Advancement of Children honored Tom for his dedication to the Connetquot community and school district. He was also awarded the Edward Krepela Award as Citizen of the Year by the Bohemia Fire Department.

Thomas D.A. Croci, Director, was elected a member of the Foundation's Board in June 1996. He received his Bachelor of Science from James Madison University and a Juris Doctor from the New York Law School and is admitted to practice in New York. During his undergraduate tenure, he authored the P.E.A.R. Program, Preventive Education Awareness Responsibility, an Alcohol Abuse Prevention Program for the Iota Beta Chapter of the Sigma Chi Fraternity. This was included in a grant application by James Madison University to the U.S. Department of Education.

As a law student and staff editor of the New York law School Reporter, Tom authored an article: "Lawyers at the Bar," which detailed lawyer alcoholism. Tom was a volunteer for the New York State Bar Association Lawyers' Assistance Program, which encourages lawyers with alcohol and drug addictions to seek counseling and treatment. Mr. Christopher B. Smithers is Vice President/ Secretary of the Foundation. He was elected a member of the Foundation's Board in May 1 987. He is a member of the Executive Committee of the R. Brinkley Smithers Institute for Alcohol-Related Workplace Studies, ILR School at Cornell University. Mr. Smithers was appointed a member of the Advisory Board of The Christopher B. Smithers Chemical Dependency Education & Training Center at CARP (Comprehensive Alcoholism Rehabilitation Program, Inc.), West Palm Beach, Florida in 1997, and is also a member of the Advisory Board of CARP's Board of Directors.

Ms. M. Elizabeth Brothers Vice President of The Christopher D. Smithers Foundation, also serves on the Boards of the Warren and August Hume Foundation and the Bach Festival Society. She is also Co-Chairman of the Financial Luncheon Group and Vice President of the Central Florida Chapter of the American Association of Individual Investors, both of which are dedicated to increasing financial literacy, as well as a member of the Development Committee of the University Club of Winter Park. She is the Club's first woman member and the first woman to be elected as its President

After holding senior development positions at Mount Holyoke college and Rollins College, Ms. Brothers became a planned giving consultant. She is the recipient of many awards for professional accomplishment and volunteer service, including the Brakeley Award for Creative Fund Raising, the National Society of Fund Raising Executives' Outstanding Professional Fund Raiser of the Year Award, the University Club of Winter Park's Community Service Award, the William Fremont Blackman Medal from Rollins College and the Cam Lusk Award from Club #1066 of Toastmasters International. A graduate of Vassar College, she is also an honorary member of the Mount Holyoke College Alumnae Association and an honorary alumna of Rollins College.

Joseph J. Calandra, M.D., Director was elected as a member of the Foundation's Board in April 2001. He received his Bachelor of Science degree summa cum laude from the State University of New York at Albany and a Medical Doctor degree from New York Medical College.
